# **INDICATOR 8 FACT SHEET**

# WHAT DOES THIS INDICATOR MEASURE?

Indicator 8 measures the percentage of parents with a child receiving special education services who report that schools facilitated parent involvement as a means of improving services and results for children with disabilities. To calculate Indicator 8:

- (1) Take the number of respondent parents who report that schools facilitated parent involvement as a means of improving services and results for children with disabilities;
- (2) Divide that number by number of respondent parents of children with disabilities;
- (3) The result is the percentage of parents with a child receiving special education services who report that schools facilitated parent involvement as a way of improving results for children with disabilities.

All public schools, including charter schools, must provide parents with the opportunity to take the Parent Involvement Survey after an initial or annual Individualized Education Program (IEP) meeting. Parents with more than one child receiving special education services should submit one survey for each child. It is important to note that parent responses are recorded anonymously and cannot be personally linked to their child.

#### WHAT ARE THE DATA CONSIDERATIONS?

#### **Data Source**

Data are collected using an online survey for parents with children with disabilities. The survey may be taken online or through a paper copy.

- School Year 2023-2024 paper surveys are red. Please do not use surveys from previous school years.
- The paper surveys are individually coded. Please do <u>not</u> make copies of the surveys, as it will invalidate and duplicate responses.




#### **Parent Involvement Survey Handout**

# HOW DOES HAWAII COMPARE TO THE NATION?

It is difficult to determine a comparison between Hawaii's performance to other states as there is wide variability in the ways that states collect data and report data for this indicator. <sup>1</sup>States use a variety of methodologies and measures to determine their performance on this indicator. Based on the most current OSEP's analysis on FFY 2019, 95% of the sates use a survey, while 5% do not. 35% distributing surveys using census methods, including mailing survey information to all parents of students receiving part b services and including the survey as part of annual IEP meetings with parents. 52% reported using sampling methods, including random samples, stratified random samples, cohorts, and other strategies. 5% reported no survey used, and unknown for the remaining 8% of the states.
