Mehnda ma institution pwukat me kin kihda skuhl laud kin kilengwohngte irail kan me mih nan pwihn ke 11 oh 12, kosonned mweidada irail en pil ale ire pwukat sang pwihn teikan ni ar katehlapala wehwehn “tohnskuhl kan en secondary skuhl.” Wehwen tohnskuhl kan en secondary skuhl kak wehwehki tohnskuhl kan me pidelong de iang pwihn ke wenou lel ke walu, oh pwihn ke duwau lel eisek riau.
